My name is Nancy Rivard and I am the founder and President of Airline Ambassadors. Airline Ambassadors is a non-profit organization recognized by both the U.S. Congress and the United Nations. The organization has over 1,200 members made up of airline personnel, health professionals, businessmen, teachers, students and others. Airline Ambassadors helps children in need at home and abroad. We hand deliver humanitarian aid to clinics and orphanages and escort children to the United States for medical treatment.

I am writing this letter on behalf of Jim Rinaldi. In April of 1999, we scheduled a humanitarian mission to Nepal. Jim Rinaldi was instrumental in assisting the group leader of that trip map out the mission. Jim left for Nepal in October of 1997 to work on other projects for another non profit group. In addition to those tasks, he made time to help with the Airline Ambassadors trip.

Jim first identified and visited villages in the remote Solu Khumbu region of Nepal that were in desperate need of medical and school supplies.
